Old Business: President Lebrun called the meeting to order at 1635 hours. Steve Holton conducted roll call, results above. Steve Holton made a motion to approve the minutes from the previous annual meeting as posted on the website, Dick Brown seconded the motion. The motion passed.

Treasurer Jace Dicken provided the Treasure's report. Dick Brown made a motion to approve the report, seconded by Jessie Jette. The motion passed.

President Lebrun announced that Ty Hultman's term as secretary was up for election this year and Ty would not seek re-election. Jace Dicken nominated Steve Holton for the Secretary office, seconded by Dan Whitted. Dick Brown made a seconded motion to close nominations. Steve Holton was elected Secretary for the term ending in 2025.

President Lebrun opened nominations for District 3 Representative currently held by Dick Brown. Steve Holton nominated Dick Brown seconded by Jace Dicken. A motion from the floor was seconded to close nominations. Dick Brown was elected to represent District 3 for the term ending in 2029.

President Lebrun announced Sibley Jankoviak's resignation as District 4 Representative. President Lebrun will entertain interested persons from both District 4 and District 1 (vacated by Holton) and make those appointments as outlined in the by-laws.

Scholarships for District 2 were not awarded this year because the school districts were not notified. Jessie Jette made a motion to award two scholarships for District 2 and an additional two scholarships for District 3 in 2024. Steve Holton seconded the motion which passed.

New Business: President Lebrun opened discussion for the 2024 Convention venue to be held in Great Falls or Billings, May 5-7, 2024. Dick Brown moved that the board be allowed discretion to choose the venue based on costs, which was seconded by Iverson. The motion passed.

Dick Brown made a motion to pay the bills for the cost of the conference, seconded by Steve Holton. Motion passed. Steve Holton moved to adjourn, seconded from the floor. President Lebrun adjourned the meeting at 1655 hours.
